



## 2026 Christine Timm Scholarship

Prime Financial Credit Union (PFCU) believes in recognizing academic excellence and community involvement. The *Christine Timm Scholarship* aims to provide financial support to students who demonstrate leadership and integrity. **Be one of three (3) recipients of a \$1,000 scholarship!** Please read all contents of this scholarship packet carefully. Incomplete submissions may result in disqualification.

### Eligibility Requirements

1. Must be PFCU primary or joint account holder at time of application.
2. Applicant must be pursuing secondary education at an accredited 4-year, 2-year or technical school in the 2026 – 2027 school year.
3. Applicant must have a cumulative grade point average of 3.0 or above on a 4.0 point scale at the end of the most recently completed academic term (semester, trimester, or quarter).
4. Must be a Class of 2026 graduating high school senior.
5. Recipients will participate in an award ceremony at the Annual Meeting and/or provide a photo for media use.
6. Application along with supporting documents must be complete, signed and returned to any PFCU branches by **March 30, 2026**. Applications may also be emailed to **marketing@primefcu.org** or mailed to the addresses below. Mailed applications must be postmarked no later than March 30, 2026.

- ☐ **4. Official Transcript** –Transcript must include the name of the high school you are attending, your anticipated graduation date and cumulative GPA at the end of the first semester.
- ☐ **5. Personal Essay (Maximum 2 page, 12-point font, double space)** – Your essay must address the following topics:
  - 1) Your academic, career or personal goals
  - 2) Your contributions to your community such as volunteer work, assistance in community programs, etc.
  - 3) How you plan to make a difference with your education
- ☐ **6. Proof of Acceptance/Enrollment:** Copy of acceptance email/letter or Proof of Enrollment certificate from your anticipated school of higher education.
